NOTE Job site construction should be completed before the dental equipment installation (including finished floors, ceiling, plumbing, lighting, paint, etc.).



7 -1/2" (191 mm) depth minimum.

Air	Protrude 1" to 2" (25 mm to 51 mm) for $1/2$ " (13 mm) compression.	 Right-angle manual shutoff valve with 3/8" compression outlet supplied and installed by the contractor, with the top of the handle no higher than 3-3/4" (95 mm) above the finished floor.
		 80-125 psi (550 to 860 kPa), 2.5 scfm (71 SL/min) minimum, during normal use (7.5 scfm [210 SL/min] peak intermittent flow).
		 Flush lines prior to making connections to dental equipment.
Electrical (optional)		 Conduit, electrical box, and power receptacle supplied and installed by the contractor (wired as per code).
		 Electrical box should be oriented vertically, with the top no higher than 5" (127 mm) above the finished floor.




Utility Placement and Elevation








Remote Floor Box Utility Connections




A-dec 342pro/342, Cabinet Mount






A-dec 342pro/342, Wall Mount




A-dec 542, Cabinet Mount




Cabinet-Mount Bracket and Wall-Mount Backboard


Cabinet-Mount Bracket Template

- 1. Print the Mounting Bracket Template on page 12 or 13.
- 2. Align the template with the front edge of the cabinet. Make sure to orient the template from the front of the cabinet.

Wall-Mount Backboard Requirements




WARNING You must mount the backboard securely to permanent wall studs. A-dec will not assume responsibility for any damage resulting from the use of incorrect fasteners.


Backboard mounting location:

- Maximum arm extension as measured from the backboard:
 - A-dec 542: 45-1/2" (1156 mm) for a 13" (330 mm) rigid arm
 - A-dec 542: 54-1/2" (1384 mm) for a 22" (559 mm) rigid arm
 - A-dec 342pro/342: 60-1/4" (1530 mm)
- Recommended distance from the bottom of the backboard to the floor is 5" (127 mm). Adjust its position according to the office space and the preferences of the doctor.


Backboard and Bracket Mounting Position Options

Distances are measured from the edge of the backboard to the center of the rigid arm position in the mounting bracket.
